Post: Jr. Executive (Civil)

Vacancy: 1(one).

Essential Qualification: First class Bachelor's Degree or equivalent grade in Civil Engineering from a recognized University/Institute.

AND

Minimum 1 years' experience as Engineer/Graduate Engineer in Metro Rail Corporations or Metro Construction/ Consultancy Company.

Desirable: Working Knowledge of relevant Design software applications like Auto CAD, STAAD etc.

Age: Not exceeding 28 years, age relaxation will be provided to reserved category like SC/ST/OBC as per the norms of Central Government.

Terms of Employment:- The selected candidate will be placed on probation period for three months with consolidated pay of **Rs.25,000/- per month.** At the end of probation period and satisfactory performance, the candidate will be placed in the IDA pay scale of **Rs. 16000- 30770** for the remaining period.

SELECTION PROCESS AND CONDITIONS:

- 1. The selection methodology will comprise two stages interview and medical examination. In case, large number of suitable applicants apply for this post, further screening by conduct of written examination and/or Group Discussion will be conducted before the interview.
